SCHOOL FEES FOR 2019

St. Bernadette's School is a non-profit organisation. Fee payments from parents is essential income required to provide the level of teaching programs, student support and physical facilities which parents expect to be available to their children. **Each family has a moral obligation to their fellow parents** to fairly meet, to the best of their ability, their share of the fees - remembering that any fee concessions or unpaid debts are in fact borne by other families.

Prompt payment of accounts is required to provide adequate cash flow for the School to enable it to meet its financial obligations as these become due. If at any time, parents find that they are not able to meet this requirement, they are asked to contact the Principal to discuss the matter immediately.

An Account for a full year of tuition fees plus levies will be issued at the beginning of the school year. Annual fees and the school levy may be paid as follows:

(a) **Five payments** made as follows:

School Levy	At beginning of School Year (by February 28)
First instalment	End of Term One
Second instalment and eLearning Levy	End of Term Two
Third instalment	End of Term Three

(b) **OR** by ten payments to be made by the second last working day of each month from February to November inclusive.

(c) By direct debit organised via the school office.

The school levy is **payable at the beginning of the school year. This fee is \$255 per child (2019)** – this forms the levy for excursions, copying, internet costs, materials, etc.

The **eLearning levy** of \$85 is a **per family** levy payable **by the end of Term Two**. This levy covers costs associated with subscriptions to electronic learning programs.

Special Allowances will be granted for families experiencing genuine financial hardship. Such allowances will generally apply to tuition fees only and will be reviewed annually. If special circumstances exist, an alternative arrangement for payment may be agreed to by the Principal. Please contact the school office to arrange an appointment.

FEE SCHEDULE FOR 2019 by Instalment

School Levy **\$255 per child** (payable by February 28)

Instalment One **Fees: \$475.00**

Instalment One is to be paid by end of Term One

Instalment Two **Fees: \$475.00**

eLearning Levy **\$85 per family**

Instalment Two and eLearning Levy is to be paid by end of Term Two = \$560

Instalment Three **Fees: \$475.00**

Instalment Three is to be paid by end of Term Three
